CampusConnection Hold – Financial Obligation Agreement

A **Financial Obligation Agreement** (FOA) has now been incorporated into CampusConnection. This requires students who register for classes to acknowledge that they understand registering for classes results in a financial obligation.

The FOA can be found in CampusConnection under Finances > My Account by selecting "Financial Obligation Agreement". Then, select "Minot State University" in the drop down menu for the Institution. To enter the Effective Term click on the Q to select the appropriate term. After clicking on "Submit" students can read the agreement before clicking to "Accept" or "Decline".

The FOA service indicator (also known as a hold) will be automatically removed once the student accepts the FOA for that term. If students decline they will not be able to enroll in classes for that term. Each semester students are required to accept the financial terms and conditions outlined by MSU in order to continue their enrollment. Students will not have access to enroll until they have agreed to the FOA. By accepting MSU's financial agreement, students are agreeing to pay for services rendered by MSU and to abide by all policies and procedures. Purpose of the Academic Advisor Handbook

The Minot State University Academic Advisor Handbook is designed to provide academic advisors, faculty and staff with the tools they need to be successful advisors. It is to serve as a useful reference for advising-related questions and facilitate continuous, ongoing advisor training. The handbook is intended to help advisors articulate policies and procedures; define and practice effective advising; find correct, accurate, concise, and consistent information; locate referral resources; and provide standardized assistance to students. College Student Inventory

The College Student Inventory (CSI) is an assessment given to first year students at CONNECT/Orientation sessions that identifies the strengths these students have, the challenges they may face in their first year at MSU, and their receptivity to interventions. The purpose of the CSI is to help students connect with the university and identify those services students may need.

One responsibility in advising first year students is to share the results of the CSI with first year advisees. Administrative Assistants have access to print both the Student and the Advisor/Counselor Reports. Academic advisors should contact first year advisees and set up a meeting to discuss their results, preferably in the first few weeks of the semester. During the meeting please spend time talking about the students' educational background and their strengths and weaknesses. Make sure to include information about available resources on campus and in the community and ensure the students that you, as their academic advisor, will be there to provide support throughout their academic career at Minot State.

Attached is a **CSI Advisor's Guide** and a campus resource handout. This guide is designed to assist advisors with understanding the purpose of the CSI and how to use this tool when working with first year advisees. Advising Distance Education Students

The Center for Extended Learning (CEL) employs dedicated advisors for specific distance-related programs as follows:

MSU Online

Students pursuing a BGS or business degree online are advised by the Online Degree Advisor. Students pursuing the Associate of Science (AS) in Human Services with a Major in Intellectual/Developmental Disabilities (IDD) online degree are advised by the department (the department employs a dedicated advisor for the AS in IDD program). Students pursuing a Master-level program online are referred to the program director in the appropriate department.

Minot Air Force Base (MAFB) Two dedicated advisors are located on the MAFB.

MSU at BSC

MSU programs offered on the Bismarck State College campus are managed by a coordinator and several program-specific advisors are located on the BSC campus.

MSU at NDSU

MSU's Social Work Department and NDSU's Human Development & Family Science Department have teamed up for a collaborative degree program with a dedicated program-specific advisor.

SI was first implemented in the Fall 2011 and has proved to be quite successful. The following chart highlights the overall grade data for SI attendees versus non-SI attendees from Fall 2011 through Spring 2014.
